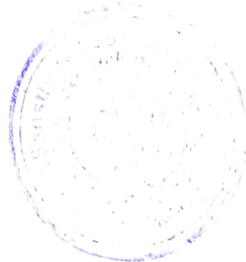

Note:- Permissibility of posts as per Government Decision dated 3.11.2018 While deciding, it is brought to your notice that the said sanctioned posts are not final as the review of the posts has not been finalized.

1. The workload of the present is calculated taking into consideration the subsidized faculties/departments/subjects working in the college and the number of enrolled students.
2. The number of students certified by the university in the faculty/department/subject mentioned in the proposal submitted by the college for designation is mandatory in the actual college.
3. The number of students required for grant and the maximum number of students should be taken into consideration for calculating workload.
4. The batch (group) of the number of students prescribed as per the government rules will be mandatory for the demonstration.
5. The time schedule for lectures, demonstrations, tutorials, project work (project work) must be as per the rules prescribed by the government.
6. According to the criteria for sanctioning the college, it is necessary to certify the list of reservation points through the prescribed authority as per the prevailing reservation policy of the government.
7. The permissible number of posts will be reduced in case of reduction in the number of students in the next academic year or in case of reduction of staff in the aided department due to other reasons.




8. According to the prevailing policy of the Government as per the sanctioned post no appointment shall be made without the prior permission of the Government. If irregularities are found in the appointments to such sanctioned posts, the said matter will be invalidated in the determination of grant. The responsibility of appointing the committee will be the responsibility of the concerned management and the college.

9. Allowances are made based on the grant-eligible workload of the college. For recruitment to permissible posts, it is necessary to submit a proposal and obtain a certificate of approval separately as per the prevailing policy and procedure of the government.
